SEACON and its member partners from eight countries in the South East Asian (SEA) region carried out a research and advocacy project entitled “**The Impact of ASEAN Free Trade Area (AFTA) Agreement on Small Scale Producers in SEA**”.

SEACON, a region wide civil society network that monitors the activities of multilateral and regional institutions embarked in this research and advocacy project because we are critical of trade liberalization that undermines efforts for sustainable agriculture, land reform, food security and food sovereignty.

In comparison to the General Agreement on Trade and Tariffs/ World Trade Organization (GATT-WTO), ASEAN Free Trade Area (AFTA) agreement is less understood in the SEA region. Pro-AFTA groups cite five major reasons favoring AFTA, namely bigger market, cheaper inputs, more investments, greater efficiency and increased benefits to the consumer. Anti-AFTA groups believe AFTA will lead to closure of companies, reduce employment opportunities, increased level of debts, decreased quality of goods and food security threats.

Uncontrolled trade liberalization is threatening food security in many parts of the world. Traditionality, small scale producers consume what they yield or catch, with extras sold to the market but at present times, trade agreements have forced them to sell what they yield and buy what they eat. Small producers in this region are no longer able to practice subsistence farming.

SEACON believes that SEA's small scale farmers and fisher folks practising subsistence farming/fishing feed the people in this region and those around the world with their production and catch. Hence, it is timely policies and strategies formulated by the SEA governments favor and protect them from being marginalized, displaced and thrown into deeper poverty.

It is in this regards that this conference aims to provide a platform for the rural people, activists, policy makers, academicians and other stakeholders to deliberate and discuss issues pertaining to AFTA and other trade agreements, food security and livelihood of small scale producers in the SEA region. We are expecting that the participants of this conference will join effort with us to push our notion of food sovereignty and fair trade principles to the rest of the world. Specifically we aim to share and disseminate our AFTA research findings and to obtain inputs from stakeholders in order to enrich our findings.
